KEY FACTS—NEW PATHWAY

- >>> The new policy allows registered nurses from NMBA-approved jurisdictions to get AHPRA registration without NCLEX RN and OSCE.
- The NMBA (Nursing and Midwifery Board of Australia) approved comparable jurisdictions are the United Kingdom, Ireland, the United States, Canada (British Columbia and Ontario), Singapore, and Spain.
- The RN must have practiced as a registered nurse for at least 1800 hours in NMBA-approved jurisdiction since January 1, 2017.
- >>> The applicant must complete the regulatory examination process for internationally qualified registered nurses in any of the NMBA-approved comparable jurisdictions. (for example, UK-CBT and OSCE).

Or

Must obtain relevant qualifications (e.g., BSc Nursing) from NMBA-approved jurisdictions that led to the general registration as a registered nurse in the NMBA-approved jurisdictions.

- >>> English language skills are required, and expired language test results may also be acceptable based on different assessment criteria.
- >>> There will be additional requirements, including good standing certificates, employer verifications, police checks, etc.
- >>> The new pathway will be effective from April 2025.
